



Quality Wood Products One Year Limited Warranty

Premier Cabinets Inc., d/b/a Quality Wood Products, Inc. ("Warrantor") warrants to the original purchaser or authorized agent of the original purchaser of its products that all products manufactured or supplied by Warrantor, and any hardware installed on such products, will be free from defects in material and workmanship under normal use for a period of one year after the date of installation. If proof of the installation date is not available, the date of product installation per the records of Warrantor will be used as the warranty commencement date. This Limited Warranty is not transferable to subsequent owners.

If any product covered by this Limited Warranty is defective due to a covered warranty condition, such product will, at the option of Warrantor, be repaired to its original condition or replaced with a comparable new product, discounted on a pro rata basis and excluding labor costs, or, at Warrantor's option, Warrantor will issue an appropriate credit. Warrantor cannot be held responsible for replacement product that may not exactly match installed product. In the event the product's finish was supplied by a third party, such warranty applies to the unfinished product as supplied by Warrantor. The warranty on products finished by Warrantor applies solely to the general tone and expressly excludes any variations in color due to wood characteristics, including but not limited to grain patterns, density and type. After expiration of this Limited Warranty, any defects in the hardware installed on the products covered by this Limited Warranty shall be the responsibility of the original equipment manufacturer.

This warranty does not cover defects or damage caused by misuse, abuse, negligence, alterations, environmental conditions, moisture or heat-related damage, normal wear and tear, accidents, acts of God, or unauthorized repair, alteration or modification, as determined by Warrantor.

THIS LIMITED WARRANTY IS THE EXCLUSIVE LIMITED WARRANTY OF WARRANTOR. WARRANTOR EXPRESSLY DISCLAIMS ANY AND ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING WARRANTIES OF FITNESS, MERCHANTABILITY, OR FITNESS FOR A PARTICULAR PURPOSE. THIS WARRANTY DOES NOT INCLUDE LOSS OF TIME, LOSS OF USE OF EQUIPMENT, INCONVENIENCE, OR ANY INCIDENTAL AND CONSEQUENTIAL DAMAGES.

Some states do not allow limitations on how long an implied warranty lasts or the exclusion or limitation of incidental or consequential damages, so the above limitations and exclusions may not apply to you. This warranty gives you specific legal rights, and you may also have other rights which vary from state to state.
